





* The D.C. district court denied a motion for preliminary injunction by Ms. English to enjoin the President from recognizing the appointment of Mr. Mulvaney. That case is currently on appeal at the D.C. Circuit. Separately, on June 21, 2018, a New York district court held the CFPB's structure unconstitutional, contrary to a prior D.C. Circuit decision. Mr. Mulvaney's term as Acting Director expired on June 22, 2018, but he may serve until his replacement is confirmed. See 5 U.S.C. § 3346.
